

## **End User Licence Agreement (EULA): PSC Applications**

This EULA forms the AGREEMENT between you and No2ndPrize Limited. By downloading the software and installing it (whether as a trial version or as a permanently licensed copy), whether it is PSC Lite, PSC Std or PSC Pro, you agree to be bound by the terms of this AGREEMENT. If this is not acceptable, please delete the original downloaded files.

This software and its attendant electronic manual and any on-line instructions (together the MATERIALS) is, and remains, the property of No2ndPrize Limited. It contains valuable Intellectual Property (IP) developed by, and for which Title vests solely in, No2ndPrize Limited. This IP may be protected by Patent (whether filed or granted), Trade Secret, and/or Copyright. By downloading and installing this software you undertake not to copy, distribute, re-sell, reverse engineer or decompile the MATERIAL or any part of it, except according to the terms of this AGREEMENT.

### **Trial Version**

Each version of PSC comes as a fully-featured integrated Trial and Full version. For the duration of the Trial period, you may use this exactly as you would use the Full version, with no constraints as to how many PSC Opportunity files you create, where you store them on your network, how many times you open the PSC or how long you use it for (subject to total Trial Period). At the expiry of the Trial period, the Trial version will no longer function and you must either purchase a licence for a full version or delete the downloaded files. Note that a subsequent Trial version download will recognize the pre-existent Trial version and will not function. You may keep any PSC Opportunity files you may have created such that you (or any colleague) can access them as soon as a Full version licence has been purchased.

### **Full Version**

Once you decide to purchase a licence to your chosen version of PSC, the "Buy" process requires that you send a "Request Code" to No2ndPrize. Once payment has been received, an "Activation Code" will be sent to you. Once this is entered into the pre-installed software, you will then have a permanent PSC licence for the designated compatible computer. IT IS YOUR RESPONSIBILITY TO ENSURE YOUR REQUEST CODE IS CORRECT. Incorrect Request Codes will result in non-functioning Activation Codes but only ONE Activation Code can be provided per purchased Licence. No2ndPrize is not responsible for non-functioning software as a result of an incorrect Request Code being submitted.

Once a Trial Version is Activated, it becomes a Full Version, which remains active as long as the licence is on the defined compatible computer. In the case of an individual changing computers, the licence may be de-installed from a computer and transferred to a new one. Individual Licences are by default backed up so that upgrades or changes to user profiles do not normally invalidate it.

### **User Files**

All versions of PSC work by the user creating individual Opportunity files. You may store these in any location you choose on your business network; make backup or archive copies of them as you wish; send them to other individuals within your organization who have a valid licence (Full or Trial) on their compatible computers; attach them to CRM opportunities. The information contained in these individual Opportunity files is regarded as Confidential Material to your organization and is not, and does not become, the property of No2ndPrize Limited, nor does No2ndPrize Limited have any responsibility for it.

User files created under one version of PSC are not readable by a different version of PSC. It is therefore the responsibility of each customer organization to decide which version of PSC they will select for use. Provided all users have licenced the same version, individual PSC Opportunity files may be freely read by all licences users having access to any shared storage place. IT IS THE RESPONSIBILITY OF THE LICENCEE TO ENSURE ACCESS TO CONFIDENTIAL INFORMATION IS RESTRICTED.

### **Warranties**

The MATERIALS are guaranteed free from computer viruses and are provided on an "as is, where is" basis. No warranty as to eventual business outcomes or to fitness for any particular purpose is provided and other liabilities are disclaimed to the full extent of applicable legislation. Any further version downloaded is provided under this AGREEMENT or any update thereto which is included in future "click-through" windows at the point of download.

This AGREEMENT is to be interpreted under English Law. This AGREEMENT terminates 9,999 days from the date of first download unless terminated earlier by the deletion of the MATERIALS from the user's computer or otherwise by mutual consent
